Comprehensive Crisis Response System

New York State is developing a comprehensive crisis response system, available to all New Yorkers regardless of ability to pay.

OMH and OASAS are committed to developing a statewide crisis system of expanded, enhanced and connected services composed of:

- Telephonic triage through the implementation of 988
- Mobile crisis teams
- Crisis residential programs
- Crisis stabilization centers
- Other community services and supports

Crisis Stabilization Centers (CSC)

- Part 600 Regulations: joint regulations with OASAS and OMH
- Two types of Crisis Stabilization Centers are being developed:
 - Supportive Crisis Stabilization Centers (SCSC)
 - Intensive Crisis Stabilization Centers (ICSC)
- **This RFP is specific to the development of SCSCs.**
- **Proposals for ICSCs were submitted 6/9/22.**



Supportive Crisis Stabilization Centers

SCSCs offer:

- Voluntary crisis treatment services, with an emphasis on peer support that is resilience and recovery oriented.
- Services provided 24 hours a day, in a safe and therapeutic environment.
- SCSC services are available 24 hours per day, 7 days per week, 365 days per year.
- SCSCs provide urgent intervention to adults, children, adolescents and families experiencing challenges in daily life.
- Rapid access to services to assist in diversion from a higher level of care.

Crisis Stabilization Services

All CSCs Provide:

- Triage and Assessment
- Medical screening
- Therapeutic interventions including crisis counseling, psychoeducation, crisis de-escalation/intervention
- Peer Support Services
- Ongoing observation
- Care collaboration with recipient's friends, family or care providers (with consent)
- Discharge and aftercare planning

SCSCs Contract to Provide:

- Psychiatric Diagnostic Evaluation and Plan
- Psychosocial Assessment
- Medication Management
- Medication for Addiction Treatment
- Medication Administration and Monitoring
- Mild to Moderate Detoxification Services

Peers Specialists and Peer Advocates

- Integral part of the Crisis Stabilization Model.
- Peers have lived experience with individuals and families across the lifespan experiencing mental health and/or substance use crises.
- Peers are the leading experts on resilience and recovery-oriented support.
- Their expertise should inform every aspect of CSCs, including administrative oversight, training development, and service delivery.

Services for Children, Adolescents & Families

- All SCSCs are expected to serve children and adolescents.
- All SCSCs are required to have a designated waiting areas and treatment areas for children and families, separate from adults.
- Staff with expertise and training in child and adolescent development must be available 24/7.
- SCSCs will collaborate with the following providers, including but not limited to:
 - Schools
 - Pediatrician offices
 - Child or adolescent mental health and substance use providers



SCSC Staffing

- Staffing plans will be created based on the program needs identified through collaborative community planning and demographic composition of the service area.
- Peers must be part of the SCSC program development and staffing plan.
- Comprised of a multidisciplinary team able to meet service area needs.
- Establishment of staffing patterns will be based on 24/7 operations.

SCSC Staffing

Required Staff Include:

- A Program Director.
- At least one Psychiatrist or Psychiatric Nurse Practitioner (PNP), a Credentialed Alcoholism and Substance Abuse Counselor (CASAC), and a Certified or Credentialed Peer Specialist on-duty and available.
 - On-duty means the individual is either physically present or on-call and available, which includes the ability to come on-site as needed.
 - The Psychiatrist or PNP may function in a supervisory and/or consultative role.
- A Registered Nurse (RN) on-site twenty-four hours per day, seven days per week.

Collaboration in SCSC Program Development

- Participation in county and community planning, active collaboration in Community Service Boards including Local Service Plans is crucial to serving community needs.
- Agencies are expected to collaborate with the Directors of Community Services (DCSs)/ Local Government Units (LGUs) in the Economic Development Region, ***before and during***, SCSC development.
- Centers will collaborate with the following:
 - OMH Field Offices and OASAS Regional Offices
 - Law enforcement agencies
 - Emergency Medical Services (EMS)
 - Schools
 - Hospitals
 - Other community programs and providers

Supportive Crisis Stabilization Center RFP

OMH and OASAS is making funds available for the development of 12 SCSCs:

- 3 Centers in the NYC Economic Development Region
- 9 Centers outside of NYC, in the remaining Economic Development Regions

Eligibility

Eligible applicants are:

- Not-for-profit agencies with 501(c) (3) incorporation and Public Benefit Corporations with experience providing mental health and substance use services to persons with serious mental illness and/or substance use disorders;
- Licensed, certified or otherwise authorized by OMH, OASAS or NYS Department of Health;
- In compliance with the application certification requirements of the Offices; and
- In good standing at the time of certification approval.

Awardees need a joint operating certificate to provide services, under Part 600.

- Certification process should begin immediately after award notification.
- SCSCs are expected to be operational by May 2023.

RFP Funding

Award includes:

- One-time start-up funds: \$1.25M
 - Providers must commit to meet start-up spending requirements.
- State-aid: \$900K (downstate) or \$768K (upstate)
- Capital funding, if needed, will be available for up to \$1,000,000 to be spent within 12 months of the capital contract execution.
- Revenue from Medicaid and other third-party payors.
 - Providers will be expected to bill Medicaid.
- Draft Crisis Stabilization Center Rates are available on the OMH website.
