Internship Program Admissions

Western New York Children's Psychiatric Center(WNYCPC) is a New York State Office of Mental Health facility that provides comprehensive care for children, adolescents, and their families in both inpatient and outpatient programs. The aim of our training program is to provide Interns with comprehensive clinical training in the delivery of empirically based, culturally competent, individualized clinical services to children, adolescents, and families. The training program offers a varied experience in the inpatient, outpatient and Day Treatment programs at WNYCPC. The Psychology Department of WNYCPC sponsors two full-time doctoral clinical internship positions in psychology and helps facilitate a smooth transition from doctoral study to professional functioning, through acquisition of advanced clinical skills that integrate theory and practice. As a member of the Association of Psychology Postdoctoral and Internship Centers (APPIC), WNYCPC participates in the National Matching Service in its selection of

psychology interns. Applications are reviewed for prior experience and demonstrated interest in working with Children, Adolescents and their families. Consideration is based on previous clinical experience, recommendation letters, personal statement, and doctoral academic performance. Based on this review, applicants are invited for on-site or virtual interviews, which are conducted in January. The interview is a chance for applicants to meet with our faculty, tour our facilities, and get to know what our program has to offer. The interview process allows the WNYCPC faculty to consider applicant's goodness of fit to the training program. Internship appointments are for one-year and begin in August and end in August the following year. The Program abides by the guidelines and policies of the Association of Psychology Postdoctoral and Internship.

The program accepts applicants who are eligible to participate in the Match Service. Applicants must have three years of graduate training, preferably with prior practicum experience working with children and adolescents and a minimum of 325 Intervention hours as well as 75 assessment hours. Preference is given to applicants with experience with psychological assessment with children and adolescents, demonstrate maturity and professionalism and have skills regarding multicultural issues. Interns with these qualities will have experience in line with our program's aim.
