Services

Dear Health Plan Administrators,

Effective July 1, 2022 and January 1, 2023, the Office of Mental Health (OMH) outpatient service rates, which will be reflected in the premiums upon State and Federal approvals, have been increased consistent with the 2022-23 Enacted State Budget. This letter is being sent to alert Medicaid Managed Care Plans (MMCPs), including Mainstream Medicaid Managed Care Plans, Health and Recovery Plans, HIV Special Needs Plans, and Medicaid Advantage Plus (MAP) Plans¹, of the adjustments to ensure compliance with the statutorily required payment of government rates.

July 1, 2022 Rate Update:

January 1, 2023 Rate Update:

- Mental Health Outpatient Treatment Rehabilitation Services (MHOTRS) Selfhelp/peer services, per 15 minutes (Procedure Code: H0038)
- Mental Health Outpatient Treatment Rehabilitation Services (MHOTRS) Selfhelp/peer services (Group), per 15 minutes (Procedure Code: H0038-HQ)

Per Chapter 57 of the Laws of 2019, MMCPs are required to pay claims based on the effective date of the rate changes. As a result, MMCPs must complete necessary systems edits to ensure payable claims for dates of service July 1, 2022, and thereafter for CPEP, and January 1, 2023

and thereafter for MHOTRS, are reimbursed at the newly effective rates. Additionally, MMCPs are required to conduct retrospective reconciliation to adjust payment for claims as necessary by April 26, 2023.
