Dear Health Plan Administrators.

Upon final approval by Centers for Medicare and Medicaid Services (CMS), the behavioral health outpatient service rates will be increased as part of Section 9817 of the American Rescue Plan Act of 2021 (ARPA) (Pub. L. 117-2)¹. This letter is being sent to alert HARPs and HIV-SNPs of the adjustments to Community Oriented Recovery and Empowerment (CORE) Services and Adult Behavioral Health Home and Community Based Services (BH HCBS) to ensure compliance with the statutorily required payment of government rates. Rates for CORE Services and BH HCBS are being increased based on models developed by New York State.

Per Chapter 57 of the Laws of 2019, HARPs and HIV-SNPs are required to pay claims based on the effective date of the rate changes. As a result, HARPs and HIV-SNPs must complete necessary systems edits to ensure CORE and Adult BH HCBS claims are reimbursed at the newly effective rates as listed above. HARPs and HIV SNPs are required to conduct retrospective reconciliation to adjust payment for claims as necessary within 90 days of receipt of this notification.
