

### ***What's New for the 2011 PCS?***

1. Replaced old item **"First Initial"** with new item **"First Name."**
2. Replaced old item **"Last Initial"** with new item **"Last Name."**
3. Item **"Current Living Situation"**:
  - a. altered choice **"NYS Office of Children & Families (OCFS) foster home"** to **"Agency Operated Boarding Home through DSS/ACS (Foster Home)."**
  - b. altered choice **"Institutional setting for youth: OCFS, DSS, or Juvenile Justice Facility"** to **"Institutional setting for youth: OCFS Juvenile Justice Facility."**
  - c. added new choice **"Institutional setting for youth: OCFS Residential Treatment Center."**
  - d. altered choice **"Youth community-based residence (OCFS, DSS, NYSED)"** to **"Youth community-based residence (OCFS, DSS)."**
4. Item **"Parental Status"** is changed to be a **"Select that all apply"** item.
5. Item **"Current Employment Status"** (note: this item now instructs to "Select the *first* outcome that applies.)
  - a. combined old choices  
**"1. Competitive employment (employer-paid position) with no formal supports"**  
**"2. Competitive employment (employer-paid position) with ongoing supports"**  
**"3. Community-integrated employment run by a state or local agency (agency-funded positions only)"**  
into  
**"Competitive and integrated employment."**
  - b. combined old choices  
**"4. Non-integrated employment run by state or local agency (Sheltered Workshop, Affirmative Businesses, Enclaves, Mobile Work Crews)"**  
**"5. Sporadic or casual employment for pay (includes odd jobs)"**  
into  
**"Other employment."**
  - c. Combined old choices  
**"8. Not in Labor Force: retired, homemaker, student, incarcerated"**  
**"9. Not in Labor Force: disabled, psychiatric inpatient"**  
into  
**"Not in Labor Force: unemployed but not looking for work, retired, homemaker, student, incarcerated, or psychiatric inpatient"**
6. Added new item **"Usual hours worked per week."**

7. Item **“Committee on Special Education Classification”**:
  - a. added choice **“Autism Spectrum.”**
  
8. Item **“Current Disabilities/Disorder”**:
  - a. altered choice **“Mental Retardation”** to **“Intellectual Disability/Mental Retardation.”**
  
9. Item **“Chronic Medical Condition”**
  - a. divided old choice  
**“1. Cardiac and metabolic illnesses (High Cholesterol, High Blood Pressure, Diabetes, History of Stroke or Heart Attack, Obesity [If BMI is known, 30 or above, if not then subjective judgment])”**  
into  
**“Hyperlipidemia (High blood fat/High Cholesterol)”**  
**“High Blood Pressure”**  
**“Diabetes”**  
**“Obesity [based on BMI\*, if not then subjective judgment]”**  
**“Heart Attack”**  
**“Stroke”**  
**“Other Cardiac Condition”**
  - b. deleted choice **“Active Tobacco Use”**
  
10. Added new item **“Smokes cigarettes or uses tobacco products?”**
  
11. Added new item **“Received a medication or a prescription for medication for smoking cessation from this program in the past year?”**
  
12. Added new item **“Received counseling for smoking cessation from this program in the past year?”**
  
13. Item **“Cash Assistance Benefits”**
  - a. added choice **“Veteran’s disability benefits”**
  
14. Item **“Health Insurance Coverage”**

- a. Under the sub-item “Does client receive Medicaid?” a conditional item was added for “If ‘Yes,’ is it Medicaid Managed Care”?

15. Deleted Item “**Is client enrolled in an HMO or Managed Care?**”

16. Item “**Criminal Justice or Juvenile Justice Status**” (note: this item now instructs to “Select the *first* outcome that applies.)

- a. altered choice “**Criminal Procedure Law (CPL) 330.20 Order of Conditions & Order of Release**” to “**Criminal Procedure Law (CPL) 330.20**”
- b. altered choice “**County/City Jail or Court Detention Prisoner**” to “**County/City Jail, Court Detention or Police lockup Prisoner (including CPL 730 and CL 508 referrals)**”
- c. altered choice “**Parolee (adults and Juvenile Offenders on parole)**” to “**Parolee (adults)**”
- d. altered choice “**Probationer (adults, Juvenile Delinquents and PINS on probation)**” to “**Probationer (adults)**”
- e. changed the 3 old choices of
  - “**Adjudicated Juvenile Delinquent or Juvenile Offender in Juvenile Justice Facility**”
  - “**Adjudicated PINS or Juvenile Delinquent in youth residential facility *other than* Juvenile Justice Facility**”
  - “**Adjudicated Juvenile Delinquents or PINS on OCFS Aftercare**”into the 2 new choices
  - “**PINS (Person in Need of Supervision)**”
  - “**Adjudicated Juvenile Delinquent or Juvenile Offender**”
- f. altered choice “**Alternative to Incarceration (ATI) status, Mental Health Court, PINS Diversion**” to “**Alternative to Incarceration (ATI) status, Mental Health Court, *Court* Diversion**”
- g. added choice “**Other criminal justice status**”
- h. deleted choice “**On Bail, ROR, conditional discharge.**”
- i. deleted choice “**Under arrest.**”
