PSYCKES-Medicaid Release Notes – Release 7.8.0

1. Social Determinants of Health (SDOH) Section Added to Recipient Search

A new Social Determinants of Health (SDOH) section has been added to Recipient Search, allowing for SDOH domains and/or conditions to be applied when running group cohort searches! The SDOH section uses Z-codes in Medicaid billing as a data source. In Recipient Search, the SDOH section will be displayed directly beneath the Characteristics section. This section will function similarly to the diagnosis or service setting filters, where SDOH domain categories will appear in a 'tree' structure and can be expanded when clicking on the "+" sign to view SDOH conditions within that domain.

When running a search using the SDOH section, users will have the ability to select a domain category or expand the domain category to select a specific SDOH condition within that domain. Up to 4 different SDOH filters can be selected at one time. The SDOHs include societal and environmental conditions that can impact a wide range of health risks and outcomes. They will be organized into the following 18 domain categories:

- Problems related to upbringing
- Problems related to social environment
- Problems related to physical environment
- Problems related to other psychosocial circumstances
- Problems related to medical facilities and other health care
- Problems related to life management difficulty
- Problems related to housing and economic circumstances
- Problems related to employment and unemployment
- Problems related to education and literacy
- Problems related to certain psychosocial circumstances
- Persons encountering health services for other counseling and medical advice, not elsewhere classified
- Personal risk factors, not elsewhere classified
- Perpetrator of assault, maltreatment and neglect
- Other problems related to primary support group, including family circumstances
- Other nutritional deficiencies
- Occupational exposure to risk factors
- Adult and child abuse, neglect and other maltreatment, suspected
- Adult and child abuse, neglect and other maltreatment, confirmed

Note: Certain SDOH conditions are considered specially protected (ePHI) data and will require signed consent or clinical emergency access to view clients meeting criteria.

2. Special Populations Section Created in Recipient Search

A new Special Populations section has been created in Recipient Search to accommodate the new SDOH section, and to assist users in more easily locating high need/high risk population filters. The Special Populations section contains filters currently in the PSYCKES application, that have been relocated from the Characteristics section.

The Special Populations section will include the following filter options:

- Population
- High Need Population
- AOT Status
- Alerts



• Homelessness Alerts

The Characteristics section will now display the following filter options:

- Age Range
- Gender
- Race
- Ethnicity
- Region
- County

3. New Service Setting: Intermediate Care Facility for Intellectually and Developmentally Disabled (ICF/IDD)

The new Intermediate Care Facility for Intellectually and Developmentally Disabled (ICF/IDD) service settings have been added to the Recipient Search Service Setting filters, Utilization Reports, and the client-level Clinical Summary:

- **Recipient Search:** In the "Services by Specific Provider" or "Services by Any Provider" sections, the following **ICF/IDD** filters are available within the "Service Setting" filter box under the "Living Support/Residential" category:
 - ICF/IDD Community Day Svcs
 - ICF/IDD Community Residential Svcs
 - ICF/IDD Institutional
 - o ICF/IDD Other
- Utilization Reports: In the Utilization Reports "Provider Network" and "Service Setting and Volume" tabs, ICF/IDD service settings are now included in counts and available to select as service settings.
- **Clinical Summary:** If applicable, the following **ICF/IDD** services will be displayed in the "Living Support/Residential Treatment" section:
 - Day Service DD Intermediate Care Facility
 - o Residential Service DD Intermediate Care Facility
 - Institutional DD Intermediate Care Facility
 - o Other DD Intermediate Care Facility
