Statewide Reports

Overview

Statewide Reports provides users with a color-coded New York State map and tabular reports that highlight variations in prevalence rates for a selected quality indicator. Quality indicator information is available at the region, county, network, provider, and Managed Care Plan level. Users designated as state-level users (e.g., OMH leadership) can also view quality indicator information at the level of the prescriber and provider attending.

Statewide Reports Filters

To use Statewide Reports, click on the "Statewide Reports" tab of the PSYCKES-Medicaid menu header (Figure 1). The screen will display the filters listed below. All selected filter conditions are carried forward to the map and tabular QI reports.

- Indicator Set (mandatory field)
- Indicator Type
- Region
- County

- Managed Care Program
- MC Product Line
- Program Type
- Age group

When an option in the Indicator Set filter is selected, the sub-indicators for the selected Indicator Set will populate in the Indicator Type filter. Similarly, when an option in the Region filter is selected, the County filter will display counties in that region.

Click "Submit" to generate a statewide report based on the selected filters. Click "Reset" to reset all filters.

Note: A link to "Indicator Definitions" will open a PDF with definitions for each indicator set and its indicator types (Figure 2).

The Map




Figure 3. Statewide Reports: Map by County

The map of New York State provides a visual representation of the percentage of positive cases flagged for the selected quality indicator, organized by county (Figure 3). Hovering the mouse over any of the counties will have a small box appears providing the following details about each county:

County name
The percentage of the eligible population meeting criteria for the selected indicator set in that specific county
The number of individuals from the eligible population who meet the criteria for the selected indicator from that specific county
The designation as a 'High Rate County' is based on the comparison of the county's percentage to the statewide percentage and represents whether the county's percentage is statistically higher compared to the state prevalence for a specific indicator

Tabular Reports

The section below the map provides information on the selected quality indicator in tabular form (**Error! Reference source not found.**). All users will see five tabs: region, county, network, provider, and plan. State-level users will see two additional tabs: prescriber and provider attending. For each tab, data pertaining to the State will always be displayed at the top of the table, followed by data pertaining to each region, county, network, provider, or plan.




Figure 4. Statewide Reports: Tabular Reports

The following information is provided in a table, under each tab:

Region Tab: Region Name, Eligible Population, # with QI Flag, %

County Tab: County Name, Eligible Population, *#* with QI Flag, %, Rate High, Region, Region %


Network Tab: Network Name, Eligible Population, # with QI Flag, %, Rate High

Provider Tab: Provider Name, Eligible Population, *#* with QI Flag, %, Rate High, County, County %, Region, Region %

Clicking on any region, county, network, or provider within a tab will take users to the QI Overview screen for the selection made. Agency level users will be able to view summary statistics for each indicator but will not be able to view clinical summaries for any clients outside of their agency.

Plan Tab: Plan Name, Eligible Population, # with QI Flag, %, Rate High

Clicking on a Managed Care plan name from the Plan tab will take users to the QI Overview Screen for the selected plan. Once the QI Overview screen is displayed for the selected plan, users can select Indicators for additional information including a list of agencies serving recipients enrolled in that plan (Error! Reference source not found.).

State-level users will also see the following tabs in Statewide Reports:

Prescriber Tab: Lists prescribers entered on pharmacy claims for clients that meet criteria for selected filter and lists the Prescriber Name, Profession, License, NPI #, County, Eligible Population, # with QI Flag, %, and Rate High

Provider Attending Tab: Lists individuals entered as "attending provider" on Medicaid claim(s) for services provided to clients, based on the selected filters and lists the Provider Attending Name, Profession, License, NPI #, County, Eligible Population, # with QI Flag, %, and Rate High

Export Options*

Users can export the Map and Tabular data PDF or users can export just the tabular data to Excel by clicking on the corresponding icon on the top right corner of the screen.




Figure 7. Exporting the Excel
